HIGHLIGHTS OF APRIL ANNUAL CONFERENCE!

The April 20 and 21st Annual conference of the Iowa AAUW was distinguished by several very special features.

- Over seventy persons attended the Saturday sessions, an increase of about one third from the previous year. Equally encouraging was the attendance at the Friday Leadership Workshop of a group of forty eight branch leaders. Nothing short of "glamorous" would describe the variety of costume and regalia that people wore to identify their branches in this 125th anniversary year!!!!
- Diane Patton, Rockwell City Branch, was chosen as President Elect during the business meeting.
- Lida Sigg, Educational Foundation Director, announced that the Bolton Sackett Research & Projects Endowment Fund has received sufficient funding from the branches of Iowa to enable it to be completed this year.
- Branches received recognition for their contributions to Legal Advocacy Funding this year.
- Norma Coret introduced fifty year members.
- The newly organized branch at Loess Hills was introduced.
- The news that Iowa AAUW has received a \$10,000 community action grant for the Marshalltown community project, Latinas al Exito, was announced.
- Iowa candidates for Association office, Florine Swanson and Myrna Sandvik were introduced.
- A variety of substantial ideas were provided in four workshops and several speeches. Many ideas provided substantial direction for the future.

DON'T FORGET! THE NEXT GENERATION OF AAUW LEADERS IS GRADUATING IN YOUR LOCAL COLLEGE NOW!

Here are some ideas which might make that connection with them stronger!

- 1. The "Give a Grad a gift" encourages branch members to give a few outstanding senior women a gift membership, thus introducing them to AAUW. Last week I visited an Iowa where such gifts were given by four branch members to four outstanding women from the local college. Doing so recognized their achievements and at the same time created a positive image of the AAUW, The branch offered to connect them with a branch wherever they moved.
- 2. The National Conference for College Women Student Leaders is approaching. It will be held in DC June 7-9. The cost is \$350 per student. Could you contact your local college Dean of Student Affairs and encourage him or her to identify such a women leader. Scholarships are available for the women. - 3. If your college is sending women, invite that woman to visit you and your branch next year.
- 4. Sometime, over the summer, try to meet with the College or University Liaison Person (contact DR. Laura Browne <u>laurabrowne@ ia.valley.edu</u> for their names) and or the College or University President or Dean and describe the AAUW's interest in the education of women and girls in their institution. Invite their partnership!
