High Priority- IRS Reporting Requirements for branches before November 15, 2008:

Beginning with FY 08, each AAUW branch with annual gross receipts of less than \$25,000, are required to start filing electronic notices, Form 990-N, also known as an e-Postcard. The IRS website address for the form is http://epostcard.form990.org. This form must be filed electronically; there is no paper form and no other notice from the IRS. The fiscal year filing is based on the Association '08 fiscal year, July 1, 2007-June 30, 2008.

To assist branches who are now required to file, Linda Bors, Association Finance Vice President, sent a memo to branch finance officers noting the importance of this requirement and detailing the basic information needed. When you've successfully completed the filing, keep a copy of your email receipt from the IRS in your files. If you have questions or comments, please send them to allfinance@aauw.org, which is staff support. I've heard from one branch that it takes a little bit of time, but with Linda Bors' suggestions and IRS instructions, it was easy to complete.
