# AAUW State Conference, April 21-22, 2006 "Gateways"...Achieving Success in Education, Careers and Economic Security

The 2006 AAUW IA Annual Meeting and Conference will be held in Marshalltown on Friday evening, April 21st and Saturday April 22nd. The event has such richness and depth that you will want to bring <u>several</u> people from your branch and larger community to absorb it all! The program will appeal to people (not just AAUW members) who share our passion of equity, quality education and positive societal change. So, invite community leaders and friends that share your values and especially those with whom you network to actively improve your community.

For the first time in many years, our program will begin on Friday evening with a venue you won't want to miss! Our setting is the Fisher Community Center, one of the gems of Marshalltown. The 2006 "Iowa Leadership Roundtable" begins at 6:30 pm with a wine and cheese reception hosted by Marshalltown Chamber Ambassadors. A hearty breakfast on Saturday morning includes an egg casserole, muffins, fruit and beverages. The Annual business meeting is first on the agenda so that the remainder of the day will be of interest to the wider audience. We are honored to have Mary Ellen Smyth, immediate past president of the Educational Foundation, to speak on "Putting the Pieces Together" based on her experiences with successful action projects and effective partnerships.

The entire program is enriching with dynamic breakout sessions which address many facets of our mission. We want volunteers from branches to introduce presenters and summarize highlights of the sessions for other participants. There are breaks during the day to bid on Silent Auction items.

A thirty member active member of AAUW, Mary Ellen has just completed her second term as President of the Association AAUW Educational Foundation. Today, she is the owner of The Smyth Organization, a medical practice management services company with consulting services in communication and staff and leadership development for both health care professionals and organizations. Ms. Smyth is the keynote speaker for the Iowa Conference on April 22nd and will lead a workshop.

### "A SENSE OF IOWA"

## **Breakout Sessions:**

#### "Successful Branches Are Continuously Evolving!"

Ms. Smyth will focus on why development is important to branches, to the state, and to our parent organization, including the Educational Foundation and the Legal Advocacy Fund. She will define the links between development and fundraising, suggest techniques and strategies including identifying and cultivating prospects, successful branch activities and/or searching for new ideas. She says: "Women and philanthropy is an idea whose time has come!" This will definitely be a time to share!

# "Yes, You Can!-Improving Immigrants Lives, Improving Communities with Changing Populations"

This session will tell about what AAUW-IA can do to encourage the removal of educational barriers for the new immigrants to Iowa and introduce a project that is being piloted in Marshalltown. The project has twin goals to encourage young Hispanic females to pursue education beyond high school and the empowerment of young adult Latinas in leadership roles. The project involves changing family perceptions to value education as a means for economic security and to adopt new thinking about potential roles for Hispanic females in the workforce. AAUW-IA would like to pursue an action grant to replicate this project in several branches across the state. Come to hear how your branch can be involved!

### "Advocating For The Arts Through Story Telling"

For this presentation, Ms. Korte, a master storyteller, will use accent, costume, paper cutting, paper folding, rhyme, music and props. Her stories teach and entertain, but also depict societies, near and far and how they think of their world as well as ours. Audience participation is encouraged!

#### "Health Disparities in Iowa: The Impact on Women"

This workshop will focus on women's health issues in Iowa; the connection between global and local women's health concerns; immigrant and refugee health issues and current projects addressing the needs. Ms. Miller brings a wealth of insight because of her roots in Iowa and extensive travel and mission trips abroad.

#### "Women and Work in Iowa's Economy"

Participants in this workshop session will review and discuss key economic policy trends in Iowa and nationally and their impact on women, including access to education, wage equity in the workplace, unpaid labor of women and social security as it affects womens' economic security.

# Challenges To Quality In Iowa's Education Pre-School, K-12

Mr. Hoover will address the status of education in Iowa and issues including early childhood education, achievement issues, Title IX, local control vs. state control and the effect of vouchers on public education. He works with the state legislature to keep them apprised of needs and issues facing educators.

# AAUW: A Key Player in Community Conversations about Quality Child Care

In fall 2005, over 300 Iowans in 12 community forums deliberated the public issue of improving the quality of child care. The forums were jointly sponsored by Iowa State University Extension, the Iowa Association of Family and Consumer Sciences, and the American Association of University Women. Three policy approaches for helping communities enhance the quality of child care were discussed: increasing government regulation; enhancing parent education; and facilitating parental care. Forums were held in Council Bluffs, Des Moines, Davenport, Dubuque and in eight rural communities which included: Algona, Burlington, Decorah, Eldora, Keokuk, Keosauqua, Ottumwa, and Tipton. Participants reflected a broad range of the population, including parents, grandparents, child care providers and professionals, school personnel, community and civic leaders, and legislators. However, child care advocates were in the majority.

#### Common Themes

Several common themes surfaced in the forums:

- the necessity of adequate funding to ensure quality care, including the need for subsidies to assist low-income families.
- the need to educate parents and the public about what to look for in quality care.
- the need for increased training for child care providers.
- the need for increased regulation that is consistent, enforceable and yet flexible to allow families choices to meet their needs.
- a need for societal change in our values regarding the importance of children and the care they deserve.

#### Value of Forums

One third of the forum participants who responded to the post evaluation questionnaire following each forum reported they were thinking differently about the quality child care issue after participating in the community conversation, and 60% indicated they discussed aspects of the issue that they had not discussed before. Certainly just having the conversation was of benefit to individuals. Research about National Issues Forums – NIF-style forums indicates that individuals, while they may not change their minds, do feel they better understand the complexity of the issue and are open to listening to others' perspectives. Participants' comments on the questionnaire reflect this. In order for change however, individuals need to act!

There are certainly lots of possibilities for follow up action beyond these community forums. The forums are one step in a continuing conversation. For example, AAUW in one community is considering a letter writing campaign to legislators advocating for adequate and equitable funding for quality early childhood education programs.

Taking Action will be covered in the next issue of the initiative.

# AAUW Iowa Public Policy Program 2006-2008

Board Approved Draft AAUW-Iowa Biennial Action Priorities

Biennial priorities for action are chosen according to the criteria of viability, critical need, strong member support, and potential for distinctive AAUW contribution.

#### **AAUW Iowa advocates:**

- Adequate and equitable funding for quality early childhood education programs
- Adequate and equitable funding for quality public education at all levels, for all students
- Increased teacher pay
- · Increased minimum wage
- · Access to affordable, quality child care
- Defense of the Family and Medical Leave Act against legislative or regulatory efforts to weaken it.
- Support for legislation which provides full-time employees with paid sick days to be used for their own medical needs or to tend to the medical needs of a child, spouse or parent. Part-time employees would receive a pro-rata share of paid sick days
- Freedom from violence and fear of violence in homes, schools, workplaces, and communities
- Expanding the Family and Medical Leave Act (FMLA) to cover biological fathers and more family and medical needs
- Choice in determination of one's reproductive life
- Promoting the economic, social, and physical well-being of all persons by ensuring a clean and healthful environment

# Seven Schools Are Members of College / University Partners Program by Melanie Guentzel

Over 550 institutions belong to the AAUW College/University Partner Program. Seven of those schools are in Iowa: Coe College, Eastern Iowa Community College District, Morningside College, Northwestern College, Simpson College, University of Northern Iowa, and Wartburg College. Institutional membership in AAUW helps further our mission of equity for women and girls as well as offering educational and growth opportunities for faculty, staff, and students. Some of this support includes: offering an American Fellowship for women doctoral candidates, a University Scholar in Residence Award for research on gender equity, and hosting an annual National Conference for Women College Student Leaders.

We recently sent branches information about supporting a woman student to attend the leadership conference.
