Advocacy in the Statehouse

On February 13, I represented AAUW at a House Education Subcommittee hearing on HSB 651. That bill would have diverted funds from public education to educational savings accounts. Essentially, it would create two different educational systems in lowa, with two different sets of rules. I was one of about 10 people who spoke in opposition to that bill. Thanks go to everyone who contacted your representatives and opposed this bill.

In November new AAUW CEO Kim Churches had an online conference call with state presidents about the future of our organization, stressing that we need to be more focused with our efforts. We followed up with a zoom conference call in Iowa. Watch for future changes at the national level about who we are as an organization.

We believe that the tradition of outstanding state leadership is exemplified in this slate.

Anne Johnson, President. Anne's Master's Degree in Public Administration and doctoral study toward Community College Leadership equipped her to serve as Director of Admission for Iowa Lakes Community College. She retired from that position in 2015. She served on the AAUW Iowa Board as Public Policy Co-Chair and president of the Palo Alto Branch. Anne has served as President Elect on the current Iowa board.

Elaine Kresse, Membership Vice President. After implementing new projects for recruitment in the past term, we are pleased that she will carry on. Elaine earned an MA from the University of Iowa. Jo Richey, Nominations Committee, SE District. Jo taught in the Des Moines public schools, serving on many committees and providing leadership in education. She is currently retired, and is the president of the Indianola Branch of AAUW.

The AAUW Iowa Public Policy Program is revised every two years. Members had the opportunity in the fall of 2017 to recommend revisions which were considered in writing the 2018-20 version. The Board of Directors submits the following AAUW Iowa Public Policy Program 2018-20 for consideration of our members at the 2018 annual meeting on April 21.

The Mission of AAUW is to advance equity for women and girls through advocacy, education, philanthropy and research.

AAUW Iowa endorses the AAUW Public Policy Program, Principles for Action and Biennial Action Priorities, which can be found on-line at www.aauw.org.

Iowa's Public Policy Program is intended to *complement* that of AAUW and be a focus of active educational and advocacy efforts for our members. The program can be found on-line at http://aauw-ia.aauw.net/publicpolicy/public-policy-program

To promote a strong system of public education and lifelong learning that promotes gender fairness, equity, and diversity, AAUW of Iowa advocates:

- 1. Adequate and equitable funding of public education, preschool through post secondary; including full funding of mandated programs, as well as programs such as counseling and the visual and performing arts.
- 2. Affordable public community college, college and university tuition and provision of programs that help women or disadvantaged students access higher education.
- 3. Opposition to use of public funding for non-public, charter, or home schools that do not meet the civil rights and accountability standards required of public schools and educators.
- 4. Availability and adequate funding for sexual health education and programs that expand opportunity for girls, including science, technology, engineering and math (STEM) education.
- 5. Vigorous enforcement of Title IX and other civil rights laws that prohibit discrimination or harassment at all levels of education; making schools safe for all students, regardless of gender, race, religious affiliation, disability, sexual orientation, and gender identity or expression.

To achieve economic self-sufficiency for all women, AAUW of Iowa advocates:

- 1. Pay equity and fairness in public and private employment compensation and benefits.
- 2. Equitable opportunities for workplace advancement, including training opportunities, and enforcement of sex/gender bias and anti-discrimination statutes.
- 3. Workplace policies that promote work-life balance, including quality affordable dependent care, adequate family and medical leave, flexible hours, and provisions for pregnant workers or new mothers.
- 4. Collective bargaining rights for public or private sector employees and the right of workers to unionize without employer intimidation or reprisal.
- 5. Funding for facilities and programs designed to transition women from the criminal justice system back to their communities, including employment training and education.
- 6. Protecting and strengthening retirement benefits and programs, including state run retirement programs.

To guarantee gender equality, individual rights, and social justice for a diverse society, AAUW of Iowa advocates:

- 1. Measures that protect, facilitate, and expand the right of all citizens to vote.
- 2. Equitable representation of women and minorities in elected, appointed, policy making, and judicial positions.
- 3. Support and funding for programs to prevent hate crimes and violence against women and children in homes, schools, the workplace, and communities, including gun violence, and to address the needs of victims of violence.
- 4. Rigorous enforcement of laws against human trafficking and support for programs to aid trafficking victims.
- 5. Access to public education and basic health and safety programs, without unreasonable requirements for proof of citizenship or other provisions beyond those included in Federal law.
- 6. Increased access to quality, affordable family planning services and physical and mental health care within a reasonable distance; including prescription medication coverage, and addictive substance education, prevention and treatment programs.
- 7. The right of a woman to make decisions regarding her reproductive life without intrusive or restrictive government regulations, including the targeted regulation of abortion providers.
- 8. Protection of the elderly through strict enforcement of nursing home regulations and stiff fines for violators.

NOMINATE A FACULTY MEMBER

FOR RECOGNITION AS A DISTINGUISHED EDUCATOR

All college/university partner schools will be notified by February 15 of the opportunity to nominate a faculty member deserving recognition as a distinguished educator. The selection committee will review the applications. Specific qualities will be evaluated. These areas are:

exemplary contributions toward creating a climate of gender equality in education through excellence in teaching.

continual efforts to develop new understandings and competencies in a discipline, and outstanding leadership

AAUW members throughout the state of Iowa are encouraged to submit applications to recognize educators who are deserving of the distinguished faculty award.

Please read over the information and submit your applications:

AAUW-lowa shall recognize distinguished faculty members each year by awarding one or more Distinguished Faculty Awards at the annual state convention.

The following guidelines will direct the process of creating and operating the committee that oversees accepting nominations for and selecting the recipient(s) of the Distinguished Faculty Award each year:

- 1. The Distinguished Faculty Award will consist of a certificate with an appropriate inscription that will be presented to the recipient(s) each year at the annual conference.
- 2. Each year, the state College and University Partner State Committee member will seek and accept nominations for the Distinguished Faculty Award.
- 3. The Distinguished Faculty Awards Selection Committee will consist of three appointed members who have no affiliation with any of the nominees. The state College and University Partner State Chair will select the committee to review the applications.
- 4. The recipient(s) of the award should be selected by the committee at least three weeks prior to the state conference. The dates of the conference for 2018 are April 20 and 21 in Ft. Dodge.
- 5. The recipient(s) of the award should be formally notified of their selection by letter by the College and University Partner State Chair and their attendance at the annual conference will be sought for receipt of the award at the conference. The nominee(s) of the recipient(s) are also to be invited to the state conference.
- 6. The College and University Partner State Chair should also notify the state AAUW president of the award recipient (s). The C/U Chair, or her or his designee, shall be responsible each year for obtaining the certificate.

The following guidelines will direct the procedures for nominating individuals for the Distinguished Faculty Award each year:

- 1. Nominees may be involved in higher education teaching at any level: community college, private or regents institution.
- 3. Nominees must teach in the state of Iowa.
- 4. Nominees need not be members of AAUW although preference may be given to nominees who are.
- 5. Nominees will be encouraged to attend the state AAUW conference to accept the award if selected.






