Your device will need to have a microphone and speakers (built in for most laptops and tablets, but added on to a desktop computer). You may

also call in from a standard phone. That will allow you to hear others and be heard, but you will not be able to see others, so it will be like a conference call. If you would like others to see you, you will need a webcam (also built in for most laptops and tablets but added on to desktops).


Palo Alto County Branch Delivers Suffrage Presentation to Middle School

Six members of the Palo Alto County Branch visited the Emmetsburg Catholic School on March 11th to deliver a presentation on women's suffrage. The presentation

covered the struggle for women's rights from the Seneca Falls Convention to the passing of the 19th Amendment. A member narrated the PowerPoint presentation which featured video clips from School House Rock and the History Channel. Between clips, other members wearing "Votes for Women" sashes gave brief biographies of some of the women who were instrumental in the movement, some of whom had connections in Iowa. One lady, Lilla Cordelia Ormsby Bliven, was from Emmetsburg! Other women highlighted were Amelia Bloomer, Mary Church Terrell, Susan B. Anthony, Carrie Chapman Catt, Julia Ward Howard, and Elizabeth Cady Stanton. Prior to the presentation, teachers had been given a list of vocabulary words to pre-teach the students in order to introduce the topic. To reinforce the vocabulary, each student was

given a word search puzzle containing key vocabulary and names from the presentation at the end of the presentation. They were scheduled to present to Emmetsburg Middle School, but the school closure made that impossible. They will consider doing that presentation in the fall.

In looking over the 2020 membership data for AAUW Iowa, welcomed me into their fold and made me feel a part of several thoughts come to mind. First, and foremost, we have lost more than one-fifth of our Iowa membership in the past three years! As you look around your Branch's members, that would mean, every fifth woman would no longer be present. This is such a tragic situation for the future of AAUW Iowa.

With the recent pandemic of Coronavirus, COVID-19, and the self-distancing that has accompanied it, I believe it is more apparent than ever, that we need physical contact; that we need human interaction; that we need stimulating conversations; that we need to continue to grow and to learn; that we need organizations like AAUW!

Since the time the data was collected in February, Iowa has lost yet another Branch. The Oskaloosa Branch has disbanded. Another 10 members deleted for the State of Iowa. I am much saddened whenever I learn of a disbanding. My original Branch in Maquoketa is one of the Branches no longer viable. When I first learned this news, I was devastated. Those women were so important to me when I lived there. They were a very diverse group in terms of occupations, ages, and experiences; although not diverse relating to race or ethnicity. I learned from them and from our excellent programs and speakers. I loved the interaction, the book discussions, the socialization. They

them. To me, that is the significance of AAUW. It is a warm, welcoming place where women can come together to feel loved and appreciated. That is a hallmark of AAUW. It is, indeed, a home for growth and learning. A place to feel connected, not only locally, but also to the important issues AAUW supports at both state and national levels.

As we emerge from our self-quarantining, our selfdistancing, and reenter the world-at-large, let us do some hard thinking, some intense focusing, on the efforts (the actions) we can take to increase, rather than decrease, our membership numbers in AAUW. Let us brainstorm and share ideas with our own Branch, with other Branches, with our State Officers. This is a perfect time for us to initiate a growth plan and implement it all over the State. Perhaps this will include the formation of "renewed" Branches, where they formerly existed. Everything is open to possibility!

The Indianola branch celebrated the 100th Anniversary of the passage of the 19th Amendment and marked Women's History Month on March 3 by doing a Wonder Women program that was loosely based on that done at the 2018 AAUW spring conference.

The twelve member cast included seven AAUW members. The remaining members included a Simpson College student, and a mother and two daughters from the community at large. The two teenage girls were wonderful presenting Malala Yousafzai and Greta Thunberg!

Approximately forty people attended the reader's theater style performance held in Lekberg Hall on Simpson's campus. Among those attending were other AAUW members, Simpson students and members of the community.

The show began with music playing as the audience took their seats. As each presenter spoke, an image of her subject was projected on a screen behind the presenters. The first part was about the fight to pass the 19th Amendment, and participants wore "votes for women" sashes. The rest of the program showed women moving on in history. Participants talked about the person, explained why they were important, and shared some quotes.

The original concept behind the Wonder Women Presentation came from President Rebecca Swainey. Rebecca coordinated the project, member Jackie Brittingham secured a location and handled the audio and video, and members Jovanka Westbrook and Lesley Leuwerke handled publicity.



Children Who Were Separated from Immigrant Parents—eNetwork Branch Program

At the April 16th online meeting of the AAUW Iowa eNetwork, branch member Ann Gale and guest Sonia Reyes from the Iowa Commission of Latino Affairs in the Iowa Department of Human Rights presented "What About the Children?"—a program focused on the plight of immigrant children separated from their families at the U.S.-Mexican border. Families face often insurmountable obstacles—such as representing themselves in immigration court. With no system in place to keep children identified as members of their own families, even a judge's order to reunite families may be impossible to accomplish. Children are kept in detention centers and sent to institutional settings around the country, where they suffer lasting psychological and developmental harm. Reyes, who is creating a network of volunteer family mentors, offered a number of ways to assist the Office of Human Rights in addressing the needs of immigrant children and their families. She invited audience members to contact her at Sonia.Reyes@iowa.gov in order to get involved.

At least a dozen guests joined eNetwork members for "What About the Children?" adding up to an audience of 30 participants for the April 16th program. The AAUW lowa eNetwork branch invites guests to join members for meetings via Zoom at 7:30 p.m. the third Thursday of each month. Update on Bylaws Action for 2020 Annual Meeting

Election of State Officers: AAUW lowa will hold a <u>virtual</u> annual business meeting for all AAUW lowa membership in 2020 because of the cancellation of the Regional Conference. This meeting will allow for election of officers for the 2020-2022 biennium. In even numbered years, the following officers are elected: President [the President-elect advances to this position], Membership Vice President, Program Vice President, Secretary and Treasurer. Also elected is a Nominating Committee to find future officers. Plan to participate.

State Bylaws Action: At the April AAUW lowa Board meeting, the Board approved a motion to postpone the voting on the two amendments to the state bylaws until the Annual Meeting in 2021. The two proposed amendments were explained on p.7 of the March *Initiative*: 1. Add the word 'elected' in Article IX. Officers Section 3. a. Terms of Officers/Directors #1: by inserting the word 'elected' before the word 'office.' and 2. Change the election of the Treasurer to odd numbered years along with the President-Elect. Discussion and voting on these amendments will take place in 2021.

State Policies: After action taken at AAUW Iowa's 2019 summer retreat, the state policy document was updated and sent to be placed on the AAUW Iowa website and to be shared with all AAUW Iowa Board members and branches in Iowa.

Status of Branch Bylaws: During 2019-2020, all AAUW Iowa branches were asked to review their branch bylaws. In November 2019, a copy of each branch's bylaws was sent to the branch president asking the branch to review their bylaws and report to the state Bylaws Director if the present bylaws were still functional or if changes are needed. In March 2020, all branches that had not replied were contacted again to remind them to notify the Bylaws Director of the status of their branch bylaws. By April 22, one branch has disbanded; 13 branches have sent notification/approval; 3 branches need to confirm the proposed changes to their branch bylaws before approval; and 7 branches have not responded. On April 22, all branches that had not responded to the request to review bylaws received a final reminder about the need to review their bylaws and report to the Bylaws Director by July 1, 2020.
