In every appropriate venue, let's gather signatures of as many lowa residents as we can! Branch leaders will soon receive information about how to transmit signatures to ACLU's reproductive freedom action team. In the meantime, we can all print off more sheets and continue gathering signatures.

Weather may prevent our going door to door to seek support, but we all have friends and friends of friends who can expand this effort far and wide. Together, let's fill hundreds of sheets with signatures of lowans who want reproductive freedom!

### AAUW Iowa Lobby Day Schedule, Wednesday, February 7, 2024

### **Schedule:**

Meet at 9:00 a.m. until 1:00 p.m. in Room 305 in the Capitol. (Note: Room 305 has been reserved for us to meet with legislators, however, should a committee meeting be called, we may have to adjust our meeting place.)

Participants will each receive an AAUW name badge or bring yours if you already have one.

We'll review tips for communicating with legislators, House and Senate procedures for contacting legislators, information about issues, and dismiss to talk with legislators.

Selected legislators may meet with us if their schedules allow.

If possible, prior to Lobby Day, schedule a time to meet with legislators you want to meet with.

Lunch is on your own. (There is a cafeteria in the Capitol.) This may be a good time to meet with legislators.

We'll reconvene in Room 305 at 1:00 for a brief wrap-up before you head home.

### Parking:

Visitor parking lots (#'s 2,6, 7, 9, 11, 15, 26, 28) are shown in green or black (3, 4, 5, 16) on the <u>lowa Capitol Complex map.</u>

### **Ground Floor Public Restroom:**

Come to the south entrance and go through security.

Go straight ahead looking for the Capitol Tours counter.

Turn left.

You will see another security station ahead.

Stay on the right side, and you will see a restroom on your right almost at the end of the hall.

#### **Meeting Room:**

To get to Room 305:

After a stop at the restroom, go back to Capitol Tours, take a left and walk to the end of the hall.

On your right is an opening. Go into it and you will see the elevator that will take you to the hallway on the side of the third floor where Room 305 is located.



# Iowa 90<sup>th</sup> General Assembly, January 8, 2024

The second half of the 90<sup>th</sup> Iowa General Assembly will convene on January 8, 2024, at 10:00 a.m. in both the House and Senate. The Democratic and Republican Caucuses have met prior to the session to outline their priorities.

**Democratic Priorities:** 

Defending and protecting public education.

Defending reproductive freedom.

Legalizing marijuana for adult use.

Lowering costs for Iowa families.

Republican Priorities:

Improving education outcomes.

Maintaining a safe and secure lowa.

Ensuring lowa's strong economy.

Keeping government transparent and efficient.

Speaker Grassley stated that feedback from their priority caucus gives reason to focus on standards and curriculum in education, especially in history and civics instruction.

Minority Leader in the House Konfrst stated they were looking at lowering costs for Iowa families to address housing, childcare and other costs facing families. Representative Konfrst also stated regarding abortion, the House Democrats have legislation filed and ready to go. Representative Grassley stated they would be taking a different approach. They will wait and see how the issue plays out in the court before they make a decision to do anything.

### Spring Conference to Honor Pioneers Maggie Tinsman and Jean Lloyd-Jones

One of the highlights of the spring conference will be an opportunity to honor two of our pioneers. Democrat Jean Lloyd-Jones and Republican Maggie Tinsman served together in the Iowa legislature, even driving together at times. They left the legislature, but they never retired from their issues. In 2009 they brought women together to form the organization, 50/50 in 2020, with the goals of having 50 women in the Iowa house of representatives and 25 in the senate by 2020, and one woman in the US Senate and a woman governor. This year Iowa woman made of 29% of the legislature. Women are 49.8% of the voters. Democrats have achieved equity in two past sessions. Their House leadership is 100% women. Republicans have taken the honors for US Senate and Governorship.

Maggie formed a consultant business, "Maggie Tinsman, LLC," and specializes in fighting Human Trafficking and as chair of the Davenport-Bettendorf AAUW Branch chairs the public policy team and specializes in getting candidates of both parties together for forums each year.

Jean worked hard to pass the ERA and served as State President of League of Women Voters and in 1986 conceived the Women's Peace Institute to "promote nonviolent resolution of conflict through conflict management, global education, international development, and world trade." She counted her ERA effort in the 100th anniversary of the passage on the 19th amendment.

You can meet these remarkable women by attending our state conference April 13th, 2024, as we celebrate their work with 50/50 in 2020.

A highlight of the conference will be a showing of a video about Maggie and Jean made by videographer Susan Wakefield, featuring the work they did for 50-50 in 2020.

### **Advocate for Victims of Human Trafficking**

As the legislature returns, now is the time to talk to them about priorities in the Justice System Budget.

For the past 3 years the Iowa Network Against Human Trafficking and Slavery (NAHT) has been advocating for the legislature to allocate \$5million in state funding to provide rehabilitative services and supports for trafficking victims. Currently Iowa does not allocate any funds to the

victims of human trafficking. The 26 Iowa programs providing services operate on shoestring budgets. The AAUW Davenport-Bettendorf Branch public policy team Maggie Tinsman, Kay Pence, Marielle



Sweborg, Suzanne Hawkinson, and Doris Mack appeal to all of us to pester our legislators to support a justice system budget investing \$5 million in state funds for crime victim services to support victims of violent crime, including survivors of domestic and sexual violence, homicide, and human trafficking.

# January Is National Human Trafficking Prevention Month What's Happening in Iowa? What Can You Do? Wear Blue!

This observance is a presidentially designated holiday whose purpose is to educate the public about human trafficking and the role we can continue to play in prevention and response. The 2024 emphasis focuses on activating partnerships to prevent and respond to human trafficking as indicated by the graphics. The international and national Blue Campaign urges people to WEAR BLUE on January 11 National HT Awareness Day to symbolize awareness, sadness, and cold-hearted traffickers.

On Thursday, January 11 the Network Against Human Trafficking will host the public signing of a proclamation by Governor Kim Reynolds designating January 2024 as Slavery and Human Trafficking Prevention Month. The proclamation signing will take place in Des Moines in the Rotunda of the State Capitol Building at 11:30 am. Maxine Lampe, eNetwork co-president, shared this information on January 8 during the Iowa Branch Presidents' Zoom Meeting.


All anti-trafficking advocates are invited to attend and wear the color blue. Y'all come in support of this issue and be present when five outstanding anti-trafficking service awards will be presented right after the proclamation

signing. The recipients are Wings of Refuge, Sparker Solutions, Kim Smith, Bernadette Rixner, and Pieper Lewis's Legal Defense Team.

Since the Iowa Legislature just convened, HT Awareness Day at the Capitol is a great time to find your legislators/or email them and share the 2024 NAHT priorities which were emailed to branch presidents by Diane Kearns, Iowa AAUW Public Policy Director January 4. An article on those priorities appears in this issue of the lowa Initiative and is posted on our lowa website. There are other HT awareness events (IowaNAHT.org) taking place throughout the state. One example includes the Siouxland Coalition Against Human Trafficking. They are sponsoring a January "light up in blue" event and are encouraging businesses, families, agencies and individuals to "light up in blue". Many blue-light storefronts are competing for the best display. Is there an event in your area? Are you taking part? Don't forget to WEAR BLUE and pass out our brochures!

Who might be likely partners in your community that you could connect with to share our information this month? Might they include the lowa caucuses, businesses, educators, youth groups, houses of worship, support groups, youth camps, schools, colleges, health care providers, EMTs, law enforcement, social service agencies, service organizations or community clubs, daycare providers, foster kids, and parents. ### The Gift—A Story

Often a story will be more persuasive than facts and logic. Perhaps this one will help you better understand why prochoice advocates are so passionate about women's rights to choose what happens to their own bodies.

#### The Gift

One evening, two figures arrive at an apartment, a police officer and a stork bearing a "gift." The officer rings the doorbell, and a man comes to the door. The stork presents the "gift" to the resident, explaining that he will be financially responsible for the "gift" because DNA identifies him as a parent. The man responds, "Hell, no! I don't want it," and slams the door. The stork turns to the officer for assistance, but the cop shrugs and says there is nothing he can do.

At another residence, the door is answered by a wearylooking woman. Children are heard playing in the room behind her. The stork informs her she must accept the "gift." She replies "No, thank you, I already have three children and almost bled to death delivering the last one." The stork insists that her health is really not a factor and that she must accept the "gift." When the woman tries to close the door, the policeman puts his foot in the entryway, and the stork forces the woman to take the gift.

The officer and stork (now with another "gift" and joined by a new companion) pass a "Welcome to Texas" sign on their way to the next residence. The woman at this apartment also refuses the "gift," saying that a pregnancy would impact her ability to do her job. When the stork insists, she counters by asking if the stork will pay her for the work to turn the "gift" into a baby. That job would require 24 hours a day for nine months, at perhaps \$5,000 per month, plus a \$5,000 bonus for the pain and suffering of the delivery. The stork replies that, no, she is expected to do the work with no compensation. The policeman informs her that she is required by law to accept this gift.

Their companion identifies himself as a bounty hunter. He will be watching her, to make sure a baby is delivered at the end of the nine months. If for any reason he suspects an abortion has taken place, he will sue and will profit from her situation. The woman is forced to accept the gift.

What is the moral of this story? Some people believe that a fertilized egg, embryo, or fetus is a person with full legal rights. Others believe just as sincerely that the egg, embryo, or fetus does not become a baby until a mother makes the transformation using her own body as the required vessel. In other words, there is only a baby if there is a mother. In a country with freedom of religion and belief, isn't it unreasonable that a minority who believe that citizenship begins at conception should dictate that belief to everyone?

In a democracy we should have the right to refuse such a "gift." Women should have the right to control their own bodies. Coerced pregnancies are not acceptable in a country where freedom is valued.

### Davenport-Bettendorf Branch Invites You to a Book Discussion



### Conference Preview—Dr. Emily Boevers

Dr. Emily Boevers, MD, FACOG, is one of the speakers at the spring conference. She will discuss "The Impact of Reproductive Freedom Policy on Women, Families, and Communities."

Dr. Boevers is a physician in Waverly, Iowa. Her role as an Obstetrician-Gynecologist unites her passion for serving the needs of rural communities and being an advocate on the local, state, and national levels for reproductive freedom.

Dr. Boevers graduated from the University of Northern Iowa with honors and continued graduate education at the University of Iowa. Postgraduate research in cervical cancer screening and prevention brought her to the University of Washington. She subsequently attended the University of Iowa Carver College of Medicine. Seeing a need for social determinants of health interventions in pregnancy, she founded the Upstream Clinic for Perinatal Health during this time as well as served in numerous

research and volunteer roles. She completed specialty training in Obstetrics and Gynecology at the University of Kansas in Kansas City.

She has been practicing at a Critical Access Hospital in Waverly, IA since August 2022. She was elected to the Iowa Medical Society Board of Directors. She is founding President of Iowans for Health Liberty and Iowa Physicians for Reproductive Freedom, organizations that support reproductive freedom.



Dr. Boevers resides in Waverly, Iowa with her three daughters and her husband, and over 200 stuffed animals. In her free time she makes and eats homemade pasta and pizza. She was the first person to check out Harry Potter and the Sorcerer's Stone from the Readlyn Community Library in 1998 and remains an avid fan.
