Because we are kicking off the conference with the documentary on Friday evening, we have also decided to add a dinner to the event. The buffet from 5:00-6:00 p.m. will offer three pizza options, salad with two choices of dressing, and bread sticks. This meal was not included in the registration fee. 

## What Is Happening in the Iowa Legislature

The legislature has begun debate on several bills. I want to thanks everyone that attended our Lobby Day. We do have another event coming up in March which is Equal Pay Day, March 18 at the Capitol.

With this article I am going to highlight bills of interest that did or did not survive the First Legislative Funnel. The Second Funnel will be March 15. All bills that are in Ways and Means are eligible for debate. I am only listing the bill number and a brief description. If you wish more indepth information, check the legislative website.

#### DID NOT SURVIVE FIRST FUNNEL:

- HF2082: Relating to gender identity and disability under the Iowa Civil Rights Act.
- HF2018: Requiring department of H and HS to reimburse county for temporary holding of, or confinement of a sexually violent predator who commits a public offense while subject to an order of civil commitment.
- SSB3085: Death penalty.
- HF2140: Summer EBT program for children (Failed to enroll by the deadline).
- HF2073: Schools districts, charter schools and innovative zone schools to employ chaplains to provide services to students.
- HF2158: Relating to voter registration activities in the schools.
- SF2027: Relating to human growth and development curriculum provided by school districts, including enrollment of students in grade 7-12 in human growth and development courses and information provided to parents.
- HF2171: Relating to child sexual abuse and child sexual assault awareness and prevention.
- HSB587: Requiring teachers and students to sing the national anthem.
- HSB633: Requiring primary elections for nomination for city, school district, and merged area elections.
- SSB3166: Relating to city libraries, including library directors and library projects. (Refers to putting libraries under city government)
- HF2130: Relating to criminal background checks for sale or transfer of firearms.
- HF2159: Relating to report requirements for lost or stolen firearms.
- SF2085: Relating to background checks for acquiring pistols or revolvers.
- HF2475: Relating to victim restitution and the rights of human trafficking victims.

- SF2135: Relating to right to contraception.
- SJR2001: Joint resolution proposing an amendment to the Constitution of the State of Iowa relating to the right to reproductive care.
- HF2293: Act increasing the minimum wage.
- There were several others of interest which did not survive the First Funnel and are included on the legislative monitor which I send out about once a week.

#### SURVIVED THE FIRST FUNNEL:

- SF2386/HF2612/HSB713: This relates to the AEA's. There have been changes from the Governor's original bill. (Debated 2/29/24, passed the House 53 Yeas, 41 Nays, 6 absent or not voting. Representative Steckman brought forth an amendment which failed.)
- HF2617: Related to pregnancy and fetal development into the human growth and development and health curriculum provided by school districts, accredited nonpublic, charter schools, and innovation zone schools to students 1-12 grades. (Debated 2/28/24, passed the House 58 Yeas, 35 Nays, 7 absent or not voting. Several amendments were brought forward by the minority party, which failed.)
- HF2562: Providing access to feminine hygiene products in public schools. (*Referred to Appropriations*)
- HF2613: Establishing school funding state percent of growth (3%). (An amendment was brought forward to allow 6%, was defeated. Bill passed the House 60 Yeas, 36 Nays)
- HF2083: Authorizing county attorney to be issued a professional permit to carry weapons. (*Renumbered HF2570.*)
- HF2586: Relates to allowing school employees to carry weapons. (Fiscal note. Debated 2/28/24, passed the House 61Yeas, 34 Nays. Several amendments were brought forward by the minority party, failed.)
- HF2558: Related to higher education, including diversity, equity and inclusion policies tuition and administrator hiring at state universities. (Fiscal note. Debated 2/29/24, passed the House 56 Yeas, 39 Nays, 5 absent or not voting.)
- HF2460: Related to human trafficking including parole and work release and victim counselors and guardian ad litem appointments for prosecuting witnesses with mental health disabilities. (Amendment filed. Fiscal note. Placed on calendar)
- HF2575: Relating to nonconsensual causing of death or serious injury to an unborn person. *Placed on calendar.*) *Continued on next page*

#### We've Come a Long Way, Ladies! March 27, 2024, 6:30 pm Lekberg Hall in the Amy Robertson Music Center

Historical songs take the audience on a journey back in time into the lives of these brave American patriots. Historical images, onstage costume transformations, an engaging spoken narrative, and audience participation make this a multi-sensory performance experience unlike any other. "We've Come a Long Way, Ladies!" has been presented at colleges, universities, arts, music, and civics organizations throughout the country. This program is presented by *Of Thee I Sing: American Heritage Through Song*, a patriotic performance platform dedicated to bringing American heritage to life through music (<u>https://</u><u>www.oftheeising.com/</u>). Of Thee I Sing has developed a unique model of historical, educational storytelling within the classical vocal genre– programming that audiences won't find anywhere else. This is not a typical recital! Audrey Johnson, a '01 graduate of Simpson, is the performer. She s a classically trained singer who has carefully curated works that help reveal the struggle of the Women's Suffrage Movement.

Program Highlights:

- Frederick Douglass's vital role and contribution to Women's Suffrage at the official beginning of the Movement.
- The role of ladies' fashions within the Movement and the strategies--and scandals--that ensued!
- The strategies employed by suffragist songwriters who used the power of music to sway the hearts of the American public
- A historic song 'from the jailhouse' which kept suffragists' spirits strong while wrongfully imprisoned complete with singing and historical 'hair-comb accompaniment' by the entire audience!

\*The program is free and open to all, however, please be advised that the program includes historical content which may not be appropriate for very young viewers.

- HF2584: Ordering or dispensing of self-administered hormonal contraceptives by a registered pharmacist. *(Several amendments filed. Placed on calendar)*
- HF2583: Relating to pregnancy women and infants under the Medicaid program. (Fiscal note. Placed on calendar.)
- SF2136: Sexual exploitation of a minor. (Renumbered SF2243.)
- HF2540: Repealing gender balance requirements for appointive bodies. (*Bill passed the house. To the Governor's desk 2-26-24*).
- SF2374: Relating to retention and recertification elections for public employee collective bargaining units. (*Placed on calendar*).
- At this point in time there have not been many new bills introduced. I check this daily on the legislative website, <u>www.legis.iowa.gov</u>. There are several ways bills can be accessed on that site. Also, on any particular bill being debated, a person can check the vote by individual legislator. This is of assistance when attending local forums and asking questions of the legislators.
